# **Recent highlights**

- WiredScores Accredited Professional Platform was setup to allow only one
  Accredited Professional (AP) to work on a certification at once. While researching
  with APs, they had mentioned that working on a certificate with the colleagues
  would be of great help. Allowing colleagues to work together would speed up
  delivery for not only APs, but the clients receiving the certificate. I researched,
  designed and tested a options that would enable APs to share with their colleagues,
  as well as allowing our Ops team to do the same if required. An efficiency gain was
  estimated to be over 10 hours for one certification.
- At Seedrs a problem identified as founders not reaching out to potential investors. As
  Senior Product Designer, increased visibility to potential investors to drive conversion.
  I understood founder's challenges and their inaction. I assessed data requirements
  and availability, engaged data and engineering, designed a dashboard and tested it
  with founders and staff. Succeeded in founders taking action (1,500 views a
  month) to reach out to their potential investors and efficiency gains for staff.
- Seedrs needed to have one place for information for unstructured data to be stored
  and accessed, to meet FCA regulatory requirements. I streamlined processes to
  capture, check and store data. Collated issues from different teams; engaged
  external suppliers on software demos; worked cross-functionally to develop
  functionality within existing in-house tool; created one source of truth; led user
  testing; and designed future automation roadmap. Succeeded in achieving
  efficiency gains of 7 hours to fulfil an FCA request.

Seedrs is an online equity crowdfunding company, intending to democratise earlystage investing for everyone, acquired by US firm Republic in 2022.

- As Senior Product Designer, led the design outcomes in the Founder team, focused on customers raising funds on the platform, reporting to the Global Retail Design Director.
- Oversaw design outcomes in the Founder team, prioritising customers who raise funds on the platform and ensuring their needs informed product and engineering decisions
- Designed and delivered process to capture investors' preferences on which campaigns they wanted to invest in, which was used to tailor future emails.
- Decreased time taken to complete a lengthy tax form by 50% through restructuring and organising the form to enable easier completion and review of data submitted.
- Implemented dashboard, increasing early communication between founders and potential investors, leading to improved conversion rates.

#### Key projects & achievements:

- Resolved issue of due diligence questions which was causing campaign fails post funding and wasted resource costs, reducing form completion time by 41% and increased same-day submissions by 67%.
